# INTRODUCTION

The Annual List of Obligated Projects is prepared pursuant to 23 U.S.C. 134(j)(7)(B) and 49 U.S.C. 5303(j)(7)(B), which require that “*an annual listing of projects, including investments in pedestrian walkways and bicycle transportation facilities, for which Federal funds have been obligated in the preceding year shall be published or otherwise made available by the cooperative effort of the State, transit operator, and metropolitan planning organization for public review.*”

This Annual List of Obligated Projects includes all projects in the Southern New Hampshire Planning Commission region for which federal funds were obligated during Federal Fiscal Year 2020 (i.e. October 1, 2019 through September 30, 2020). The Federal Highway Administration (FHWA) defines “obligated” as “*the federal government’s legal commitment to pay or reimburse the states or other entities for the federal share of a project’s eligible costs.*” This reimbursement can be for projects that have been initiated in previous years, or for projects that will not be completed until future years. The final cost of a project may be different from the amount of obligated Federal funding. Similarly, funding can be “de-obligated” for projects in response to lower-than-expected costs, project cancellation, or other extenuating circumstances.

## **Overview of the Southern New Hampshire Planning Commission**

The Southern New Hampshire Planning Commission (SNHPC) is designated as the Metropolitan Planning Organization (MPO) for 14 municipalities in southeastern New Hampshire including and surrounding the City of Manchester. The SNHPC Region extends from Franconia in the west to Deerfield in the east and includes communities along the I-93, I-293, and NH Route 101 corridors. The SNHPC MPO has responsibility for planning, programming, and coordinating federal investments and works in partnership with the communities, the New Hampshire Department of Transportation (NHDOT), New Hampshire Department of Environmental Services (NHDES), Federal Highway Administration (FHWA), Federal Transit Administration (FTA), and regional transit operators in planning and programming transportation improvements.

## **Overview of the Metropolitan Transportation Planning Process**

### *SNHPC FY 2017-FY 2040 Metropolitan Transportation Plan*

The SNHPC Metropolitan Transportation Plan is a fiscally-constrained, multimodal transportation plan addressing a 20-year planning horizon. The plan is developed and adopted by the SNHPC MPO through the metropolitan transportation planning process, and is the source from which projects are identified, prioritized, and selected for funding.

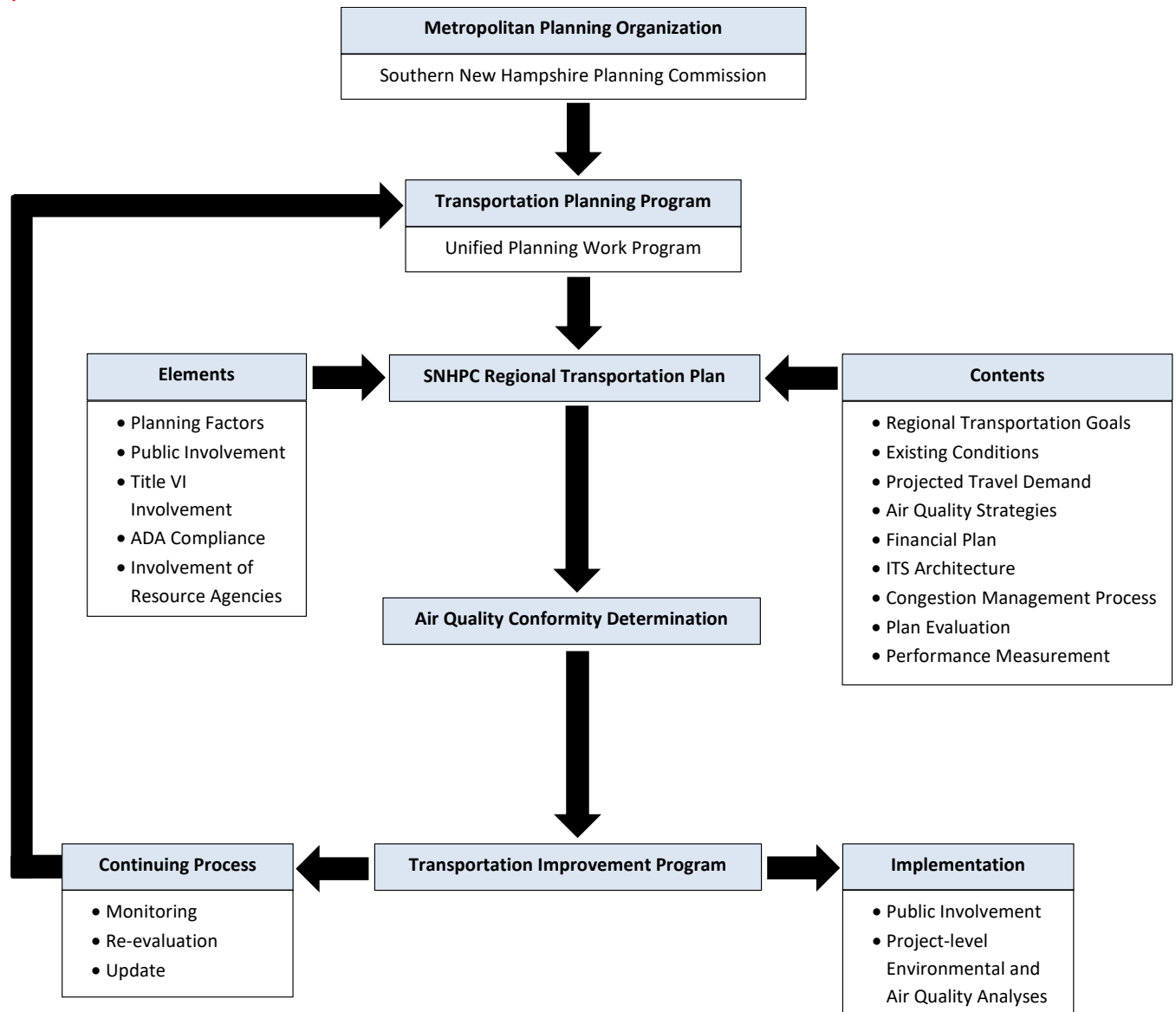
### *SNHPC FY 2019-FY 2022 Transportation Improvement Program*

The FY 2019 – FY 2022 Transportation Improvement Program (TIP) is a four-year program of regional transportation improvement projects for the SNHPC MPO Region. The TIP serves as the short-range, project-specific component of the Metropolitan Transportation Plan. Projects are selected from the Metropolitan Transportation Plan for inclusion in the TIP from a screening process to ensure that impacts associated with health, safety, welfare and the environment are evaluated and weighed in the public interest.

## *SNHPC FY 2020 Annual List of Obligated Projects*

The FY 2020 Annual List of Obligated Projects tracks the implementation of the TIP, and allows for the re-evaluation of project readiness so that project listings by phase in the TIP accurately reflect the year of obligation for funds associated with those programmed activities.

# UNDERSTANDING THE OBLIGATED PROJECTS REPORT

The Annual List of Obligated Projects was developed using data provided by the New Hampshire Department of Transportation (NHDOT) and regional transit providers. For each project, the following information is included:

- **FED #-** The federally-assigned tracking number for the project.
- **STATE #-** The State-assigned tracking number for the project.
- **CATEGORY-** A categorization of the type of project. Six categories of projects are included in this report: 1) Highway; 2) Transit; 3) Bicycle/Pedestrian; 4) Planning; 5) Research; and 6) Innovation.
- **LOCATION-** The municipality (or municipalities) where the project is located.
- **ROUTE-** The roadway, transit route, or trail where the project is occurring.
- **SCOPE OF WORK-** A brief summary of the work being completed as part of the project.
- **INDIVIDUAL OR PROGRAMMATIC PROJECT IN TIP-** A categorization of whether the project is listed-individually in the SNHPC FY 2019-FY 2022 TIP, or whether the project is a “child project” of a funding program listed in the SNHPC FY 2019-FY 2022 TIP.
- **FY 2019 OBLIGATED FEDERAL FUNDING-** The amount of Federal funding obligated for the project during FY 2019.
- **FY 2020 OBLIGATED FEDERAL FUNDING-** The amount of Federal funding obligated for the project during FY 2020.
- **TOTAL FY 2019-2022 PROGRAMMED FEDERAL FUNDING-** The total amount of Federal funding programmed for the project in all years of the SNHPC FY 2019-FY 2022 TIP.
- **FEDERAL FUNDING REMAINING FOR THE PROJECT IN THE FY 2019-2022 TIP PERIOD-** The difference between the “TOTAL FY 2019-2022 PROGRAMMED FEDERAL FUNDING” and obligations made to date during the TIP period (i.e. the sum of FY 2019 and FY 2020 obligations).
- **FUNDING PROGRAM-** The Federal funding source for the project.
- **RESPONSIBLE AGENCY-** The State agency, local government agency, or transit provider responsible for implementing the project.
