1. <u>Call to Order/Introductions</u>

Acting Chair George Sioras called the meeting to order at 9:33 AM.

2. <u>Review of meeting notes of March 16, 2023</u>

This item was tabled due to lack of an in-person quorum.

3.1 <u>2023 Bike Month Preview</u>

Ms. Tammy Zamoyski gave an overview of bike month events and activities taking place within the SNHPC region for Bike Month 2023.

3.2 <u>Electric Vehicle Charging Plan Update</u>

Ms. Zamoyski provided a status update on the draft SNHPC Region Plan for Electric Vehicle Infrastructure Development. This included a brief review of the potential charging station locations identified as part of the plan, and the criteria used to prioritize them. Locations in Bedford, Derry, Londonderry, and Manchester were discussed briefly.

In Bedford, Ms. Becky Hebert agreed that the library would be a great central location to consider installation of EV charging infrastructure.

In Derry, Mr. Sioras noted that the Marion Gerrish Center should rise to priority location #2, with the library falling to #3.

In Londonderry, Ms. Nancy Michels indicated that the Market Basket and Liquor Store at I-93 Exit 4 are adjacent and could be combined into one location.

In Manchester, Ms. Kristen Clarke noted that parking garages could be ranked higher, and that Arms Park has good potential. Mr. Jason Cleghorn asked for more time to review and comment on proposed locations.

Mr. Ricky DiCillo clarified that of the potential VW settlement locations in the SNHPC region, only two from Hooksett have been selected, but two others in Hooksett and one in Manchester could reemerge if another project drops out of the running.

3.3 <u>Climate Adaptation Case Study</u>

Ms. Suzanne Nienaber reviewed insights from the April 11, 2023 regional climate workshop, which will inform the development of a forthcoming Climate Action Toolkit focused on roadway adaptations. She also highlighted a key opportunity for SNHPC communities to contribute to the Climate Action Toolkit by participating in a facilitated case study exercise.

3.4 Traffic Counting Program Overview

Mr. David Tilton gave an overview of the 2023 program, which will involve counts at 365 locations across all 14 SNHPC communities. Mr. Adam Hlasny reviewed SNHPC's bike-ped counting program, which began in 2017 and currently consists of 70+ locations, a mixture of sidewalks and trails across the region.
