NEW BUSINESS

Draft FY2025-2034 TYP Review

Mr. Nate Miller reviewed the new projects and project changes affecting the SNHPC region in the draft FY 2025-2034 Ten-Year Plan. The last GACIT hearing is in Goffstown on 10/25/23, after which GACIT will finalize its version of the TYP (in late November/early December) and submit it to Governor Sununu. After potential edits by him, as well as House and Senate Committees, the TYP will become law as amended by 6/30/24.

Mr. Miller encouraged those present to attend a GACIT hearing, either in Londonderry on 9/27, Goffstown on 10/25, or any others around the state. Any written comments are due to Mr. William Watson of NHDOT by 11/3/23.

Mr. Peter Griffin asked when IIJA funding is no longer available, what will it look like for transportation in NH. Mr. Miller responded there are three more years of IIJA funding and there is reasonable optimism that there will be sustained funding levels in the next federal reauthorization beyond this period.

ADJOURNMENT

Motion by Mr. Ponce de Leon to adjourn the Metropolitan Planning Organization. Motion seconded by Mr. Moulton. The meeting stood adjourned at 11:48 AM.
