## GIS/Spatial Analysis

A Geographic Information System (GIS) allows for the visualization, interpretation and organization of geographic data. This makes GIS an invaluable tool for understanding relationships and patterns between disparate data that would not be readily apparent otherwise. SNHPC uses GIS on a daily basis to support planning staff and region-wide efforts.

- Maintaining/updating data for projects such as open space plans, master plans, hazard mitigation plans, zoning updates, tax mapping, road base maps, and many others.
