

THE COMMUTESMART SPRING CHALLENGE IS BACK!



CommuteSmart New Hampshire is an organization dedicated to encouraging and assisting people to choose sustainable transportation options in place of driving single occupancy vehicles. This year, CSNH is issuing their yearly spring challenge for May 2024! Compete with other businesses throughout the state to show who can log the most sustainable trips. All it takes is businesses and their employees participating in green commuting options. During the spring challenge, businesses can also participate in Bike to Work Week (May 13-17) and Bike to Work Day on Friday, May 17, 2024.

Participants can save on the cost of gasoline and have fun doing so by reducing their miles driven during the Spring Challenge. A combination of driving and biking to work also counts. Decreasing the number of cars on the road also preserves the life of our existing roadways, reduces air pollution, minimizes time spent in traffic, and most importantly keeps all of us healthier and happier. Examples of sustainable trips that can be logged include:



Carpools and Vanpools



Public Transportation



Walking



Telecommuting (working from home)



Biking

In May 2023, 383 individuals participating in CommuteSmartNH accomplished much for the environment, our health, and our wallets, all through sustainable commuting. It is amazing what 383 challenge participants can collectively do when they are committed to sustainable commuting! For example:



During last year's challenge, bike commuters reduced **9,648 car trips** by biking, and drove **71,075 miles less**, which is equivalent to:



Circling the earth 2.9 times



Driving from New York to Los Angeles **25.6 times**



67,178 laps around the NH Motor Speedway

Commuters prevented **60,674 pounds of carbon emissions**discharged to the
environment and saved **3,096 gallons of gas** from being
bought, which is equivalent to:



9.3 tons of gas



206.4 sedan gas tanks



A gas pump running for 6.5 hours

The savings at the pump and from wear and tear on our vehicles equaled a total of \$44,422 during the 2023 Spring challenge, which is equivalent to:



15.7 years of the average NH monthly electric bill



49.2 grocery trips for a family of 3



1110.6 trips to the gas pump

Through active transportation (such as walking and biking), participants burned a whopping **486,667 calories**, which is equivalent to:



2863 medium lattes from Dunkin Donuts



477 lobster rolls



1622 cider donuts

How Do I Join the Challenge?

- 1. Head over to <u>commutesmart.org</u> or download the CommuteSmart New Hampshire mobile app.
- 2. Create an account. Don't worry it's free!
- 3. Opt-in to the challenge. This can be found on the home page if you're on the desktop version or under the "more" tab in the mobile app.
- 4. Start logging your trips! The leaderboard will appear on May 1st, 2024 and will update at the stroke of midnight every day. The points earned from logging your trips can be used for:

INTRODUCING MORAL CARE SERVICE



Moral Care Service is a caregiving program that opened in Manchester in 2023. They provide hourly, overnight, and live in care, as well as elderly, disability, Alzheimer's, and dementia care. They also provide demand-response transportation for their clients.

Moral Care provides transportation to clients who need rides for:

- Physician appointments
- Medication pick-up
- Accompany to lunch or dinner
- Senior center
- Club event
- Church activities
- Community events
- Special family events
- Hairdresser/barber salon
- Grocery shopping



Moral Care serves residents of Manchester as well as those in the immediate surrounding area including Hooksett, Auburn, Londonderry, Bedford, and Goffstown.


