The concept is simple. Visit *snhpc.org,* find the button that says **I Need a Ride**, click on it, and fill out the two0minute form with the following information:


- Your name

HELLO FROM BEN, YOUR MOBILITY MANAGER



Since I started serving the region, I've worked directly with 14 individuals to help connect them to transportation. For example, an older woman who lives in Manchester needed a ride to her COVID booster appointment. After working with CareGivers NH and Manchester Health Dept., they were able to get a ride to her appointment. Now that she knows how easy it is, she will keep using their service for trips to the market.

In Sandown, the daughter of an older gentleman reached out for transportation to Boston for her father's medical appointment. He was relying on his family for rides, so all of them were looking for a new mode of transportation. I reached out to the town of Sandown, who run their own volunteer driver program (VDP). I also contacted the American Cancer Society, who also runs a nationwide VDP. The daughter was happy to learn that both were able to accommodate rides for her father.

In these cases, it isn't just 14 individuals that need assistance; it's 14 families. Often, older adults rely on their adult children and other close relatives for important rides. What happens if they aren't available to drive? This is a reality many Granite Staters face. This is what makes the work I do important to New Hampshire. I'm so happy I'm able to assist these families, and maybe I can assist yours too.

MTA recently shared news that CART's fare structure is going to change. Instead of ranging from \$3 to \$5, **CART will operate on a \$2 flat fare, regardless of destination.**




RIDERSHIP HIGHLIGHT CART COOPERATIVE ALLIANCE FOR REGIONAL TRANSPORTATION

The pie chart reflects the percentage of rides provided in each community. Derry, being the most populated town in the region, makes up the largest portion at 48.9%

The bar chart below compares each service's total ridership to the previous fiscal year (July 2021 - January 2022). Londonderry had the highest increase at 543 trips, or 93.5%. Hampstead was the only service to experience a decrease, at 62 trips, or 12%.
