How does the TIP fit into the Project Development Process?

Construction



Year 1-4

Transportation Improvement Program (TIP)

- Comprised of projects in the first four years of the TYP.
- Encompasses all federally funded projects in the region.
- Fiscally constrained in accordance with known revenues.
- Updated every two years at the conclusion of the TYP process.

Federal Requirement

Year 5-10

Ten-Year Transportation Improvement Plan (TYP)

- State-level funding commitment for listed projects.
- Encompasses all surface and air transportation projects in NH.
- Fiscally constrained against known and anticipated revenues.
- Regions are provided funding allocations for new projects.

State Requirement

Year 11-20+

Metropolitan Transportation Plan (MTP)

- Identifies long-term project needs to meet regional goals.
- Inclusion in the MTP does not constitute a funding commitment.
- Fiscally constrained against known and anticipated revenues.
- Projects in the MTP form the "pipeline of projects" for the TYP.

FY 2023-2026 SNHPC Transportation Improvement Program (TIP)

- The SNHPC has been coordinating with the NHDOT on an update to the region's Transportation Improvement Program (TIP). The update covers FY 2023-2026.
 - The Draft TIP was released for public review and comment on January 19, 2023.
 - A 30-day comment period will be held from January 19, 2023 to February 20, 2023.
 - TAC will have an opportunity to provide additional feedback at the February 16, 2023 meeting.
 - The SNHPC MPO will hold a public hearing to consider adoption of the TIP on February 21, 2023.



- Auburn (29316)
 - Bridge Rehabilitation- Griffin Mill Rd. over Maple Falls Brook
- Bedford (24217)
 - Bridge Replacement- Beals Rd. over Baboosic Brook
- Francestown (42709)
 - Bridge Rehab/Replacement- Old County Rd. North over Collins Brook
- New Boston (14771)
 - Bridge Replacement- Gregg Mill Rd. over South Br. Piscataquog River
- New Boston (15505)
 - Bridge Replacement- Tucker Mill Rd. over Mid. Br. Piscataquog River

These projects are all local bridges that are appearing in the TIP because State Aid Bridge funding previously programmed for CON phase work has been swapped with (Federal) MOBIL funding to accelerate the schedules.



Bedford (40664)

- Scope of Work: U.S. Route 3 Widening from Hawthorne Drive to Manchester Airport Access Road
- Total Funding in TIP: \$9,813,190
- <u>Construction Schedule:</u> Start in FY 2026 (and continue beyond TIP horizon)
- Changes from Last TIP: Project is fully funded and is proceeding as expected.



- Bedford-Merrimack (16100)
 - Scope of Work: Improvements to Bedford Mainline Toll Plaza to Institute All Electronic Tolling.
 - Total Funding in TIP: \$11,250,021
 - Construction Schedule: FY 2023-2024
 - Changes from Last TIP: The All Electronic Tolling (AET) option has been selected for implementation (versus the Open Road tolling option).



Bow (29641)

- Scope of Work: NH Route 3A Corridor Safety Improvements
 (This project is in the CNHRPC Region, but occurs within part
 of the Manchester Urbanized Area. Thus, the project must be
 included in the SNHPC TIP.)
- Total Funding in TIP: \$3,822,018
- Construction Schedule: FY 2023-2024
- Changes from Last TIP: The project was originally scheduled for construction in FY 2022 but is now scheduled for FY 2023-2024.



Candia (41592)

- Scope of Work: Safety and Operational Improvements on NH Route 27, NH Route 43, and Raymond Road
- Total Funding in TIP: \$500,259
- Construction Schedule: FY 2028 (Beyond the TIP Horizon)
- Changes from Last TIP: Initial PE phase work will now begin in FY 2023.



Derry-Londonderry (Exit 4A)

- Scope of Work: The former Project #13065 has been split into multiple projects encompassing different components of the Exit 4A scope of work, including:
 - Project #13065A- Final Design and Construction of a New Interchange and (a portion of the) Connecting Roadway
 - Project #13065B- Construction of the Connecting Roadway from the end of Project #13065A east
 - Project #13065C- Construction of Tsienneto Road from Project 13065B east to NH Route 102
 - Project #13065E- Building Demolitions on Folsom Road for the Construction of Exit 4A

- Total Funding in TIP:
 - **Project #13065A** \$17,159,128
 - Project #13065B- \$33,493,733
 - Project #13065C- \$22,139,915
 - Project #13065E- \$533,500
- Construction Schedule:
 - **Project #13065A-** FY 2023-2024
 - Project #13065B- FY 2024-2026
 - **Project #13065C-** FY 2025-2026
 - **Project #13065E-** FY 2023
- <u>Changes from Last TIP:</u> Project changed from Design-Build to Design-Bid-Build with phased construction.



Hooksett (29611)

- Scope of Work: Reconstruction and Widening of US Route 3/NH Route 28 from NH 27/Whitehall Road/Martin's Ferry Road to Alice Avenue
- <u>Total Funding in TIP:</u> \$6,439,506
- <u>Construction Schedule:</u> Start in FY 2026 (and continue beyond the TIP horizon)
- Changes from Last TIP: Construction schedule now begins in FY 2026.



Hooksett (43851)

- Scope of Work: Reconstruct two intersections: NH 3A/Hackett Hill Road and NH 3A/Main Street
- Total Funding in TIP: \$4,000,000
- Construction Schedule: FY 2026
- Changes from Last TIP: New project in the TIP.



Londonderry (41593)

- Scope of Work: Safety and Operational Improvements at the Intersection of NH Route 28/NH Route 128
- Total Funding in TIP: \$1,348,911
- Construction Schedule: FY 2027 (Beyond the TIP Horizon)
- Changes from Last TIP: No change from last TIP.



Londonderry (41715)

- Scope of Work: Operational and Capacity Improvements at the Intersection of NH Route 28/Stonehenge Road
- <u>Total Funding in TIP:</u> \$4,710,000
- Construction Schedule: FY 2024
- <u>Changes from Last TIP:</u> Construction delayed to FY 2024 to allow for ROW acquisition to accommodate MS4 stormwater control measures.



- Manchester (15837)
 - Scope of Work: Bridge Rehabilitation- U.S. Route 3 (Elm Street) over B&M Railroad
 - Total Funding in TIP: \$5,737,274
 - Construction Schedule: FY 2025
 - Changes from Last TIP: New project in the TIP.



- Manchester (16099)
 - Scope of Work: PE and ROW for Reconstruction of I-293 Exit 6 and Exit 7
 - Total Funding in TIP: \$11,432,879
 - Construction Schedule: Beyond TIP Period
 - <u>Changes from Last TIP:</u> Project delayed significantly due to COVID-related turnpike revenue impacts.



Manchester (24212)

- Scope of Work: Amoskeag Eastbound Bridge- Salmon Street over Road, Railroad, and Merrimack River
- Total Funding in TIP: \$12,940,003
- Construction Schedule: FY 2024-2026
- Changes from Last TIP: New project in the TIP.



Manchester (41594)

- Scope of Work: Operational Improvements at the I-293 Exit 1 Interchange
- Total Funding in TIP: \$433,435
- Construction Schedule: FY 2028 (Beyond TIP Horizon)
- Changes from Last TIP: Initial PE phase work is scheduled to begin in FY 2024.



Manchester (42881)

- Scope of Work: Construct a Northbound Right Turn Lane and Modify Lane Utilization at South Willow Street/Weston Road Intersection
- Total Funding in TIP: \$902,302
- Construction Schedule: FY 2025
- Changes from Last TIP: No change from last TIP.



Manchester (42886)

- Scope of Work: Construct a Roundabout at Entrance of Derryfield School at River Road/Bicentennial Drive Intersection
- Total Funding in TIP: \$201,960
- Construction Schedule: FY 2027-2028 (Beyond TIP Horizon)
- Changes from Last TIP: No change from last TIP.



- Manchester (43826)
 - Scope of Work: Manchester Millyard Projects funded by a RAISE Grant
 - Total Funding in TIP: \$27,463,899
 - Construction Schedule: FY 2024-2027 (Partially Beyond TIP Horizon)
 - Changes from Last TIP: No change from last TIP.



- Manchester (43850)
 - Scope of Work: Eddy Road/Exit 6 SB On Ramp Intersection Safety Improvements
 - Total Funding in TIP: \$2,684,224
 - Construction Schedule: FY 2026
 - Changes from Last TIP: New project in the TIP.



- Nashua-Merrimack-Bedford (13761 and 13761E)
 - Scope of Work: Widening two lane sections of F.E. Everett Turnpike from Exit 8 (Nashua) to I-293 (Bedford)
 - Total Funding in TIP: \$6,000,000 (Project 13761) and \$19,272,752 (Project #13761E)
 - Construction Schedule: FY 2023-2025
 - Changes from Last TIP: All work in the SNHPC region related to this project is expected to be completed in the TIP horizon. A portion of the work in the NRPC region may extend past the TIP horizon.

 - \$29,990,706 in TIP Period (State Funded)

- Scope of Work: Address Bridge Carrying NH Route 77 over Canal 2 of Choate Brook (#159/178)
- Total Funding in TIP: \$232,581 (PE Phase Work Only)
- Construction Schedule: 2028 (Beyond TIP Horizon)
- Changes from Last TIP: No change from last TIP.



- Wilton-Milford-Amherst-Bedford (13692D and 13692E)
 - <u>Scope of Work:</u> Traffic and Safety Improvements Consistent with the Intent of the 2002 Corridor Study
 - Total Funding in TIP: \$9,117,428 (Project 13692D) and \$7,390,342 (Project 13692E)
 - Construction Schedule: FY 2023-2024 (Project 13692D) and FY 2026 (Project 13692E)
 - <u>Changes from Last TIP:</u> Addition of Project 13692E as an additional project to implement improvements on the NH Route 101 Corridor



Windham (40665)

- Scope of Work: Intersection Improvements at NH Route 28/Roulston Road
- <u>Total Funding in TIP:</u> \$1,772,970
- Construction Schedule: FY 2026
- Changes from Last TIP: No change from last TIP.



- Manchester Transit Authority (MTA) Section 5307
 Urbanized Area Formula Grant Funding
 - Scope of Work: Operating, ADA Paratransit, Preventative Maintenance, and Planning for MTA and CART Services
 - Total Funding in TIP: \$22,717,518 (\$14,993,562 Federal and \$7,723,956 Local)
 - <u>Changes from Last TIP:</u> Funding increased to reflect current Section 5307 apportionment levels under the IIJA.



- Manchester Transit Authority (MTA) Section 5310
 Funding for Seniors and Individuals with Disabilities
 - <u>Scope of Work:</u> Annual Section 5310 Apportionment for Transportation of Seniors and Individuals with Disabilities in CART Service Area.
 - Total Funding in TIP: \$646,281 (\$517,025 Federal and \$129,256 Local)
 - Changes from Last TIP: No changes of significance from current TIP.



- Manchester Transit Authority (MTA) Section 5339 Bus and Bus Facilities Funding
 - <u>Scope of Work:</u> Annual Section 5339 Apportionment for Capital Vehicles and Equipment in CART Service Area.
 - Total Funding in TIP: \$208,490 (\$177,217 Federal, \$15,637 State, and \$15,637 Local)
 - Changes from Last TIP: No changes of significance from current TIP.
